Dear Sir/Ma'am,

We are pleased to appoint you as an Authorized Dealer for your region under the following terms:

1. A refundable security deposit of INR 50,000 with 9.75% annual interest must be submitted. The amount will remain with the company during your association. In case of surrender, a minimum 6-month lock-in applies. If dealership is closed within 1 year, no interest will be paid.
2. After deposit, delivery of 3.5 tons within 100 km from our Super Stockist will be free. Orders below 3.5 tons or exceeding 100 km will incur transport costs, borne by the distributor.
3. Promotional materials will be provided as per company plans and remain company property.
4. Company promotions and offers will be shared only by official staff. No verbal or third-party commitments are valid unless issued in writing.
5. Field team support will be provided as per company tour plans to assist and coordinate local activity.
6. All payments must be made online to the company account. Cash payments or third-party transfers are not permitted.
7. If goods remain unmoved for over 3 months, written intimation must be submitted. Failure to report may result in rejection of expiry or damage claims.
8. Damage or expiry claims will be accepted quarterly with valid proof. Only sealed, approved stock will be eligible.
9. Approved claims will be settled within 90 working days from receipt of complete documentation.
10. The distributor must maintain proper supply chains and ensure regular availability in the market.
11. All supply vehicles must carry company branding as per guidelines.
12. The distributor must follow ethical trade practices. Any act of duplication, parallel selling, or pricing violations can lead to termination without refund.
13. This dealership is non-exclusive unless confirmed otherwise. The company may appoint more distributors in the same area for better supply.
14. You will be assigned six beats. Each beat will include approximately 100 counters. After completing 100 counters, a new distributor may be appointed in the extended area.
